

SICPA/HARRIS CANNABIS POLL RESULTS June 2022

A new nationwide study commissioned by SICPA and conducted online by The Harris Poll of over 2,000 U.S. adults explores the consumer confusion that exists around cannabis product safety and quality standards. Consumers incorrectly assume the basic protections are there for cannabis as they exist for food, pharma, personal care, and other products.

Percentage who thinks cannabis products are grown and produced using consistent product safety standards (regardless of which state they are legally purchased in).



ENVIRONMENTAL STANDARDS

Percentage who thinks no matter where they are located, the businesses licensed to grow and produce cannabis products must meet consistent environmental standards.

- 81% Americans
- 83% American cannabis consumers



WORKER HEALTH & SAFETY STANDARDS

Percentage who believes cannabis employers are held to the same health and safety standards for their workers as every other industry.

MEDICINAL & THERAPEUTIC RESEARCH

Percentage who thinks federal government should allow more research to be conducted on the medicinal and therapeutic value of cannabis for patients with chronic pain or debilitating diseases, such as cancer and epilepsy.

- 87% American cannabis consumers




DECRIMINALIZATION VS. LEGALIZATION

Percentage who agrees on decriminalizing cannabis, whereby the drug is still illegal, but the legal system will no longer prosecute or criminalize a person for possessing a small amount of cannabis.

Percentage who supports the federal government setting standards for environmental protections that must be met by the U.S. cannabis industry in the U.S.



SURVEY METHODOLOGY

This survey was conducted online within the United States by The Harris Poll on behalf of SICPA between April 26-28, 2022 among 2,069 adults ages 18+, among whom 1,220 have ever used cannabis products. The sampling precision of Harris online polls is measured by using a Bayesian credible interval. For this study, the sample data is accurate to within + 2.8 percentage points using a 95% confidence level.
